2020-2021 REGISTRATION INSTRUCTIONS

On our St. John the Baptist Catholic School Tuition Contract for Kindergarten through Grade 8, please complete all information for SECTIONS 1 through 5. In SECTION 2, if the child is in Kindergarten, please indicate whether they will attend half day or full day. Kindergarten students may change from partial to full day class during the school year and tuition will be adjusted accordingly.

If you apply for and receive tuition assistance, our school office will make the necessary adjustments. You are responsible for regular payments until that time. Please see SECTION 4 of the Registration form if you plan to apply for financial assistance.

Family Discounts*

- 2 Children qualify for a 2% discount off full tuition
- 3 Children qualify for a 3% discount off full tuition
- And so on up to 7 children qualify for a 7% discount off full tuition

Multi-student discount applies as long as you are registered with and participating in Faith Direct (see page 2 for further details).

2% early payment discount will be applied if tuition is paid in full by July 1, 2020.



^{*}Families receiving tuition assistance do not qualify for this discount.

SECTION 3 of our Registration and Tuition Contract asks you to select your payment option. Having all families enrolled with FACTS provides accuracy and timely accounting to best serve our school families. FACTS allows a one-time tuition payment, made by July 1, 2020, to be exempt from any processing fees. Additionally, you will receive a 2% discount on your total tuition bill. A semi-annual payment plan will qualify for a 1% discount. Payments are made in August and December.

A FACTS Tuition Management account must be set up for every family, even if you are paying in full with one payment. The materials enclosed with this Registration Packet give more details. If you already have a FACTS account, you do not need to set up another account. We will enter the new school year information, and you will receive an e-mail confirmation that your new payments are ready for the next school year. All FACTS agreements must be in place by June 1, 2020, or there will be a \$75.00 late fee.

SECTION 4 of the Registration and Tuition Contract concerns families with students in grades K-8 applying for tuition assistance. Tuition assistance may be applied for online at https://online.factsmgt.com/signin/3D2CC. Assistance is based upon family need and the availability of funds.

SECTION 5 of our Registration and Tuition Contract explains our SCRIP program. Purchasing scrip is a successful way of providing an ongoing stream of revenue for our school but has virtually no impact on your budget. Our St. John's SCRIP program offers gift cards to a variety of grocery stores, restaurants, and retailers. Each merchant pays St. John's a percentage from the gift cards purchased. We ask each family to purchase \$3,600 in scrip from June 1, 2020, to May 31, 2021, which averages \$300 per month. If you are delinquent at the end of the school year your account will be assessed \$400. If you do not wish to participate in our SCRIP program, we ask for a \$400 SCRIP Assessment Fee for the year. Please call our school office at 303-776-8760 if you have any questions regarding this program.

SECTION 6 is a reminder of your Faith Direct account. We require that each family use a Faith Direct account to tithe. There is a Faith Direct Enrollment Form included in this packet. Faith Direct allows our families to contribute to our parish in a verifiable method on a weekly or monthly basis. Tithing to our parish is one factor in determining if your family will receive the Affiliated Catholic tuition rate.

SECTION 7 concerns receiving the Catholic Affiliated tuition rate. If you attend one of our many area Catholic parishes, we must have the signed Family Out-of-Parish Affiliation form returned to the school office by June 1, 2020, in order to receive the Affiliated Catholic rates. If your family is registered at St. John's and enrolled in Faith Direct, no form is needed. We will verify this information through our business office.

SECTION 3: PAYMENT WITH FACTS TUITION MANAGEMENT
All tuition payments must be set up with the FACTS Tuition Management by June 1, 2020.
If you are not yet enrolled with FACTS, please select your tuition payment plan by visiting https://online.factsmgt.com/signin/3D2CC .
If you pay in full on or before July 1, 2020, you will receive a 2% discount. To do this, you must be enrolled with FACTS.
Delinquent Payments/Accounts
 A family with a delinquent account will be denied an application for the next school year until the account he been paid in full. If a family with a child in the 8th grade has a delinquent tuition account, the tuition account must be paid in full by May 1, 2020, or the child will be denied participation in graduation activities. If a family has any past due accounts owed to the school or if all required fees are not paid, the child's name will not be placed on a class list at the beginning of the school year. St. John the Baptist Catholic School reserves the right to send a delinquent account to a collection agency for the payment at the parents' expense. A family whose account has been sent to a collection agency may not enroll at the school until all accounts are current.
SECTION 4: TUITION ASSISTANCE FOR GRADES K-8
St. John's is pleased to provide resources for those in grades K-8 wishing to apply for tuition assistance including FACTS Grant & Aid Assessment. To be eligible to apply for FACTS Grant & Aid Assessment, parents must meet the requirements for affiliated Catholic tuition. Financial aid must be applied for by April 3, 2020. Preschool is not eligible for tuition assistance. To apply for financial aid, please log in to your FACTS account at https://online.factsmgt.com/signin/3D2CC .
We will apply for tuition assistance online through FACTS (information is included in this packet).
We will NOT be applying for tuition assistance.
SECTION 5: SCRIP PROGRAM
Each family is asked to purchase \$3,600 of scrip annually from June 1, 2020, to May 31, 2021, which averages \$300 per month. If you are delinquent at the end of the school year, your FACTS account will be assessed \$400. In contrast to event-driven funding, all it takes for you to raise funds for St. John's is to acquire scrip for your purchases. Our St. John's SCRIP program offers a variety of grocery stores, restaurants, and retailers. If you do not wish to participate in our SCRIP program, you may opt out of the program by paying a \$400 SCRIP Assessment Fee.
We will participate in the SCRIP program and buy a total of \$3,600 of scrip.
We do NOT wish to participate in the SCRIP program and will pay a \$400 SCRIP Assessment Fee.

The family out-of-parish affiliation form is used to determine if a family/parent/guardian qualifies for the affiliated tuition rate as a registered member of their parish. On an annual basis, the family out-of-parish affiliation form must be submitted by the family and signed by their pastor in order for the family/parent/guardian to receive the affiliated tuition rate. Parish affiliation is defined as families who are registered members of Archdiocese of Denver Parishes and whose children are enrolled in an archdiocesan elementary school, not in their parish of membership for kindergarten or a higher grade, or one of the two archdiocesan-operated high schools. These families are eligible to receive the affiliated Catholic tuition rate if they meet the following criteria:

- 1. The family has been registered in the parish for at least six (6) months.
- 2. The family verifiably contributes, according to their means, on a regular basis to the financial support of the parish.
- 3. The family attends weekend Mass regularly and is involved in the activities, organizations, or programs at the parish.
